


#### INVESTMENT HIGHLIGHTS

- ➤ Two main level entrances on South and West. Main South entrance has reception/waiting area. Allows for separation of services or multiple tenants.
- ▶ Main floor configured with mix of 27 private offices, 7 conference/ training rooms, and 7 exam/lab rooms.
- ▶ Finished lower level with secure entry and video surveillance.
- ▶ Lower level configured with 7 private offices, 8 large meeting rooms, central admin area with built-in desks, showers, large day room with attached kitchen, and various storage rooms.
- ▶ Neighbors Monument Health Family Medicine Clinic.
